# ETHICS

## Current Cycle is

January 1, 2019 to  
December 31, 2021



REALTORS® are required to complete ethics training of not less than 2 hours, 30 minutes of instructional time. The training must meet specific learning objectives and criteria established by the National Association of REALTORS®.

Training may be completed through NAR's online courses or through another method, such as online or classroom courses via local/state associations.

Courses offered by 3rd-party providers designed for state CE credit may count towards your association of REALTORS® Code of Ethics Training Requirement, but NAR does not track such courses nor approve them. Please inform your Association so they can update your file.

### **NAR Ethics is required for all REALTOR members.**

If a new member completes the NAR Orientation between 1/1/19 – 12/31/21, the Ethics requirement would be met.

If the new member did not complete Orientation, and are still a REALTOR, they must get the Ethics somewhere, either WRA CE4 or NAR online.

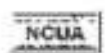

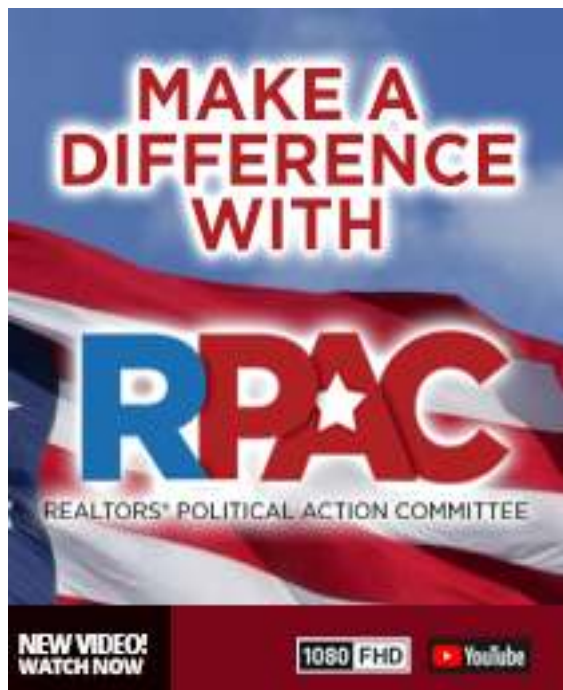
